Toolbox for professionals





In its eight chapters you will find the reflections of professionals from Spain, Denmark, Greece, Italy and Germany on the why and how to teach the national language, introducing the analysis of teaching materials, the use of technologies, the transversal importance of environmental and gender contents and underlining the need to approach this hosting process from an intercultural dialogue of knowledge for the empowerment of migrants as guests and protagonists in their process of learning the host language and culture.


